

SUMMARY ANNUAL REPORT FOR SAFEWAY, INC. WELFARE BENEFITS PLAN FOR EMPLOYEES

This is a summary of the annual report of the Safeway, Inc. Welfare Benefits Plan for Employees (Employer Identification Number 94-3019135, Plan Number 501), for the plan year June 1, 2019 through May 31, 2020. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Safeway Inc. has committed itself to pay certain medical, prescription drug and dental, claims incurred under the terms of the plan.

Insurance Information

The plan has insurance contracts with Continental American Insurance Company, HMSCA, Kaiser Foundation Health Plan Inc, Kaiser Foundation Health Plan of Hawaii, Lincoln Life Assurance Company of Boston, Standard Insurance Company, Vision Service Plan, Kaiser Foundation Health Plan of Colorado and Kaiser Foundation Health Plan of the Northwest to pay certain health, PPO contract, prescription drug, HMO contract, temporary disability, long-term disability, life insurance and vision claims incurred under the terms of the plan. The total premiums paid for the plan year ending May 31, 2020 were \$28,928,612.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending May 31, 2020, the premiums paid under such "experience-rated" contracts were \$8,150,872 and the total of all benefit claims paid under these experience-rated contracts during the plan year was \$8,840,244.
